FAMILIES COME TO OUR WAREHOUSE TO CHOOSE FROM GENTLY USED DONATED ITEMS. IN 2010, WE DISTRIBUTED 620 DINING TABLES, 1,100 SOFAS AND 1,200 DRESSERS TO FAMILIES IN NEED. BEDS - DIGNITY AND RESPECT ARE DIFFICULT TO ACHIEVE WHEN YOU'RE SLEEPING ON THE FLOOR. THIS ESPECIALLY HOLDS TRUE FOR CHILDREN. WE COLLECT AND DISTRIBUTE USED MATTRESSES AND BOX SPRINGS EACH YEAR. LAST YEAR, WE DISTRIBUTED MORE THAN 1,400 BEDS TO CHILDREN AND ADULTS WHO NEEDED THEM. CRIBS FOR KIDS - INFANTS ARE AT RISK OF INJURY OR DEATH WHEN THEY ARE SLEEPING WITH A PARENT. DURING THE YEAR, WE DISTRIBUTED MORE THAN 90 CRIBS TO LOCAL FAMILIES AT RISK, INSURING THAT MORE NEWBORNS AND INFANTS ARE SLEEPING SAFELY AT NIGHT.
