	Most students attending EARTH University come from rural parts of developing countries principally in Latin America EARTH University's mission is to prepare leaders with ethical values while contributing to sustainable development and a proper and just society Fulfilling this mission is viewed as the best way to effect long-term change that brings sustainable solutions to the developing world In 2010 54% EARTH's 386 students were provided with full financial aid (tuition, room and board), 30% received some form of financial aid while the remaining 16% of students paid for tuition, room, and board Note The term' full financial aid' refers to the share of tuition, room and board charged by the University which amounted to \$15,450 in 2010 However, this amount represents only 47% of the \$34,000 00 actual fully-allocated one year cost of education at EARTH University Since EARTH University was formed in 1990, it has a young and limited base of alumni EUF undertakes to help secure funds for the University's financial aid program In 2010, the Foundation provided a combination of full and partial scholarships to 137 students representing \$1,122,276 68 --- For the class of 2013 entering 2010, the Foundation provided approximately 39 full and partial scholarships Students benefitting from this financial aid came from 10 different countries including Guatemala, Costa Rica, Nicaragua, Ecuador, Belize, Mexico, Peru, Honduras, Colombia and Kenya
