Headwaters offered programming for 122 adults with disabilities in 2010. 65,019 hours of training and supervision were provided to these participants by our staff. Our community integration program provided 27,188 hours of training and supervision in the following areas: daily living skills, academics, enrichment, sewing, shopping, cooking, recreation and leisure activities. Our adult respite program served five families in 2010.

4b (Code: ) (Expenses \$ 875,106 including grants of \$ 0 ) (Revenue \$ 1,088,456 )  
Our work program provided diverse employment opportunities to 84 persons with disabilities. 36,615 hours of training and supervision were provided in our enterprise activities program in the following areas: light assembly and packaging, collating, confidential document shredding, mass mailing, shrink wrapping, commercial sewing, auto reconditioning, and highway rest area maintenance. Lean manufacturing principles were applied in our packaging, assembly, sewing, and auto detailing areas. Our community employment program served 39 participants and one of those received a vocational evaluation. Job placements were provided to 15 people in competitive employment. Headwater's community employment program partnered with 21 businesses in our tri-county area to develop work sites for people with disabilities seeking employment. Our transportation component provided daily transportation to 78 participants living in rural areas of Forest, Oneida, and Vilas counties to and from our facility.

Our Birth to 3 program served 139 special needs children and their families, and screened 200 children for cognitive delays. The program also provided home visitation for early head start children. Program evaluations exhibited successful outcomes in all of these programs
