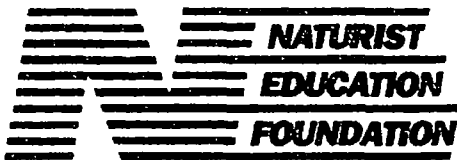

- PUBLIC OPINION POLLING

The Naturist Education Foundation continued distribution of a nationwide public opinion poll it had commissioned in 2006. The *2006 NEF-Roper Poll* updates the opinions of Americans on issues pertaining to the public acceptance of naturist values and activities.

The Naturist Education Foundation continued distribution of the *2009 NEF-California Poll*, an opinion survey that focused on California residents.

- OUTREACH / INVOLVEMENT

In 2010, the Naturist Education Foundation continued its outreach programs

- NEF continued development of a brochure especially intended to address the concerns and issues of non-naturist women.
- NEF conducted informational sessions at festivals and gatherings that served those outside the traditional naturist community.
