DISASTER RELIEF FOLLOWING THE DEVASTATING JANUARY EARTHQUAKE IN HAITI, CREDIT UNIONS AROUND THE WORLD RESPONDED WITH US\$1.2 MILLION FOR THE COUNTRY’S CREDIT UNION SYSTEM WITH SUPPORT FROM THE CREDIT UNIONS AND THEIR NATIONAL ASSOCIATION IN THE DOMINICAN REPUBLIC AND WOCCU STAFF RUNNING THE HAITI INTEGRATED FINANCE FOR VALUE CHAINS AND ENTERPRISES (HIFIVE) PROGRAM, WF WAS ABLE TO BRING IMMEDIATE RELIEF TO CREDIT UNIONS NEAR PORT-AU-PRINCE AND LEOGANE, THE EARTHQUAKE’S EPICENTER. CREDIT UNIONS, CREDIT UNION STAFF AND EVEN THE NATIONAL REGULATORY AUTHORITY RECEIVED EMERGENCY SUPPLIES AND A TOTAL OF 175 TENTS FOR CREDIT UNION OPERATIONS AND LIVING QUARTERS, ALLOWING STAFF TO RETURN TO WORK AND CREDIT UNIONS TO RESUME OPERATIONS. WF IS REBUILDING NINE CREDIT UNIONS. THE PROCESS IS HAPPENING GRADUALLY AS CREDIT UNIONS ARE CAREFULLY EVALUATED FOR LEADERSHIP, LOCATION AND SUSTAINABILITY. WF FUNDS ARE ALSO BEING COMBINED WITH FINANCIAL RESOURCES FROM CANADA’S DESJARDINS GROUP, THE U.S. AGENCY FOR INTERNATIONAL DEVELOPMENT AND HAITI’S LE LEVIER CREDIT UNION NETWORK TO CREATE A STABILIZATION FUND TO HELP RECAPITALIZE CREDIT UNIONS AND PROVIDE ADDITIONAL LENDING RESOURCES TO MORE MEMBERS AS THEY CONTINUE TO REBUILD THEIR LIVES.

PARTNERSHIP PROGRAM. IN 2010, THE WORLDWIDE FOUNDATION FOR CREDIT UNIONS (WF) SUPPORTED WOCCU’S INTERNATIONAL PARTNERSHIPS PROGRAM, WHICH MATCHES CREDIT UNIONS AND THEIR TRADE GROUPS FROM THE U.S. AND CANADA WITH THOSE IN DEVELOPING COUNTRIES TO EXCHANGE IDEAS AND TECHNICAL EXPERTISE, LEADING TO STRONGER INSTITUTIONS THAT BETTER BENEFIT MEMBERS. THE INTERNATIONAL PARTNERSHIPS PROGRAM INCLUDED 22 PARTNERSHIPS BY YEAR-END. THE INTERNATIONAL PARTNERSHIPS PROGRAM ALSO LAUNCHED A CUSTOM LEARNING EXPERIENCE PROGRAM THAT OFFERED TAILORED MINI-INTERNSHIPS TO TEACH CREDIT UNION STAFF ABOUT SPECIFIC TOPICS THEY WOULD LIKE TO LEARN MORE ABOUT IN THE COUNTRIES OF THEIR CHOICE. EDUCATION. CONTINUED SUPPORT OF WOCCU’S PACIFIC CREDIT UNION TECHNICAL CONGRESS DEMONSTRATES THE WORLDWIDE FOUNDATION’S ONGOING COMMITMENT TO TRAINING. THE CONGRESS IS DESIGNED TO INCREASE THE TECHNICAL CAPACITY OF STAFF AND VOLUNTEERS SERVING CREDIT UNIONS IN DEVELOPING COUNTRIES. IN 2010, THE FOUNDATION SUPPORTED THE CONGRESS HELD IN PAPUA, NEW GUINEA AND ALSO SUPPORTED THE NEW PACIFIC CREDIT UNION NETWORK, AN ORGANIZATION DESIGNED TO PROVIDE TECHNICAL ASSISTANCE, COMMUNICATIONS AND ADVOCACY SUPPORT AND TO DEVELOP A PACIFIC CREDIT UNION DATABASE. AN EDUCATIONAL WOCCU PROGRAM FUNDED BY THE WORLDWIDE FOUNDATION, THE GLOBAL WOMEN’S LEADERSHIP NETWORK HAS A TWO-FOLD MISSION: SUPPLY WOMEN CREDIT UNION LEADERS IN DEVELOPED AND DEVELOPING COUNTRIES WITH PEER-TO-PEER EDUCATIONAL NETWORKING OPPORTUNITIES AND SUPPORT WOCCU FIELD PROJECTS TARGETING POVERTY REDUCTION THROUGH WOMEN COMMUNITY LEADERS. IN 2010, A SECOND FORUM IN LAS VEGAS, USA, DREW 82 LEADERS FROM 21 COUNTRIES. THE NETWORK HELD ITS INAUGURAL LEADERSHIP FORUM IN BARCELONA, SPAIN, FOLLOWING WOCCU’S WORLD CREDIT UNION CONFERENCE IN JULY 2009, WITH MORE THAN 40 WOMEN LEADERS FROM 18 COUNTRIES PRESENT. THE NETWORK HAD MORE THAN 100 MEMBERS BY 2010 YEAR-END AND SUPPORTED WOCCU PROJECTS BENEFITING WOMEN IN MEXICO, KENYA AND SRI LANKA.
