HENNEPIN HEALTH FOUNDATION (HHF) SUPPORTS THE MISSION OF HENNEPIN COUNTY MEDICAL CENTER (HCMC), MINNESOTA'S LARGEST PUBLIC SAFETY NET AND ACADEMIC MEDICAL CENTER. NO ONE IS TURNED AWAY DUE TO LACK OF INSURANCE OR ABILITY TO PAY. HCMC IS HOME TO THE LARGEST AND BUSIEST TRAUMA CENTER IN THE STATE, AND TRAINS THE MAJORITY OF PHYSICIANS, NURSES AND OTHER CLINICIANS WHO CARE FOR THE CITIZENS OF THE STATE. HCMC'S HOSPITAL AND CLINICS SERVE MORE THAN 140,000 PEOPLE FROM ACROSS THE STATE MAKING MORE THAN 350,000 VISITS EACH YEAR. HENNEPIN HEALTH FOUNDATION WAS FORMERLY KNOWN AS THE SERVICES LEAGUE OF HENNEPIN COUNTY MEDICAL CENTER, INC. THE ORGANIZATION CHANGED ITS NAME, REPURPOSED ITS BYLAWS AND CHANGED ITS FISCAL YEAR TO CALENDAR, AS OF OCTOBER 1, 2009. HHF RAISES AND ADMINISTERS PHILANTHROPIC SUPPORT FOR HCMC IN MANY AREAS.
