SHELTER: WHILE WE ARE LOCATED IN ANOKA COUNTY, WE SERVE WOMEN FROM ALL OVER THE METRO AREA AND ALL OVER MINNESOTA. OUR SHELTER IS OPEN TO ANY WOMAN AND HER CHILDREN WHO NEED A PLACE OF SAFETY AND ESCAPE FROM DOMESTIC ABUSE. ALONG WITH PROVIDING EMERGENCY SHELTER FOR UP TO 45 DAYS, OUR ADVOCATES WORK CLOSELY WITH CLIENTS - WOMEN AND CHILDREN - PROVIDING ONGOING EMOTIONAL SUPPORT, ASSISTANCE IN PROTECTION PLANNING, SECURING SAFE PERMANENT, AFFORDABLE HOUSING OR RELOCATION, AND CONNECTING CLIENTS TO VALUABLE RESOURCES IN THEIR COMMUNITY. IN 2010, OUR SHELTER PROVIDED EMERGENCY SHELTER AND ADVOCACY SERVICES TO 645 WOMEN AND CHILDREN. OVER HALF OF OUR SHELTER RESIDENTS WERE CHILDREN. WE ANSWERED OVER 8,532 CALLS ON OUR 24-HOUR CRISIS LINE.

COMMUNITY SERVICES: MANY CLIENTS WHO ARE SUFFERING FROM ABUSE DO NOT REQUIRE SHELTER, BUT DO NEED ADVOCACY AND SUPPORT SERVICES, ESPECIALLY AS IT PERTAINS TO LEGAL PROCEEDINGS. THOUGH THESE SERVICES BEGAN IN THE MID-1980'S, IN 1999 ALEXANDRA HOUSE OPENED A SECOND SATELLITE OFFICE TO BETTER ASSIST VICTIMS OF DOMESTIC VIOLENCE IN FILING PROTECTION ORDERS AND NAVIGATING THE CRIMINAL COURT PROCESS. STAFF ANSWERED OVER 4,000 CALLS, PROVIDING SUPPORT, ADVOCACY, LEGAL INFORMATION AND REFERRAL SERVICES.

VIOLENCE PREVENTION: TO REALIZE OUR MISSION OF BREAKING THE CYCLE OF DOMESTIC VIOLENCE, WE DEDICATE TWO FULL TIME STAFF TO COORDINATE PREVENTION AND INTERVENTION PROGRAMS IN FOUR SCHOOL DISTRICTS, INCLUDING ANOKA-HENNEPIN, ONE OF THE LARGEST IN THE STATE. PRESENTATIONS ARE OFFERED ON A VARIETY OF TOPICS INCLUDING HEALTHY RELATIONSHIPS, CHILD ABUSE, DATING VIOLENCE AND SAFETY PLANNING. EACH PRESENTATION IS TAILORED TO SPECIFIC AGE GROUPS. IN 2010, WE GAVE 212 CLASSROOM PRESENTATIONS TO 6,549 STUDENTS AND TEACHERS.
