SCEIC, Inc. administers a countywide revolving loan fund that was primarily funded by loans from the USDA, Rural Development, Intermediary Relending Program and by donations from a local for profit development corporation. This loan program provides "gap financing" for existing and start-up businesses that obligate themselves to hiring 30% of new employees from low to moderate income individuals and farm families. The SCEIC, Inc's Board of Directors and staff use USDA Rural Development, IRP Program rules and regulations to administer the revolving loan fund.

4b (Code: N/A ) (Expenses \$ 31,706 including grants of \$ ) (Revenue \$ 30,010)  
SCEIC, Inc. operates a program called "Stevens Forward". Stevens Forward is a countywide activity made up of numerous groups and individuals working with one another in community development efforts. Stevens Forward is also an effort among the county, the five incorporated cities, and the sixteen townships in the county to ensure a successful future for our county's communities. The 14 goals of Stevens Forward are in economic development, community diversity, K through 16 education, retirement, recreation and the environment.

4c (Code: N/A ) (Expenses \$ including grants of \$ ) (Revenue \$ 86,500)  
The project is a multi-sector, comprehensive approach to sustainable broadband adoption targeting residents, small businesses, local govts, and critical services providers in rural MN. MN Intelligent Rural Communities expects to reach each of MN's 80 rural counties through education, training, technical assistance, and by removing barriers to broadband adoption. The projects will nurture & support an enhanced 'culture of use' of broadband-based services. The EDA center at the U of M, Crookston will help track the impact of the project, including # of subscribers generated. Funding is provided by a grant from Blandin Foundation as a portion of the American Recovery and Reinvestment Act of 2009 via the U.S. Department of Commerce.
