

The remaining balance of approved, but undrawn loan funds is expected to be drawn down in 2011. The \$200,000 grant was drawn down in early 2011.

There were eight loans outstanding as of 12-31-2010. A total of \$134,356 and \$26,939 in principal and interest were repaid in 2010.
