The Twin Cities Retrouvaille (TCR) program consists of these important elements: Weekend, Post, Enrichment, and Expansion.
Weekend: A weekend consists of a Friday evening to Sunday evening training experience. Couples are taught an effective communication technique called dialog. Dialog is a structured sharing of thoughts and feelings which promote trust and acceptance in a couple's relationship. Weekend sessions are presented at a local motel. Direct expenses consist of catered meals, rooms, and conference room rental. Couples are asked for a \$ 150.00 registration fee. The fee is waived for couples who cannot afford it. Couples are told the cost of the program per couple and are asked to make a donation at the end of the weekend. This one solicitation covers the cost of the entire program. TCR presented 8 weekend sessions for approximately 229 couples in 2010. A weekend presenter team consists of 3 couples and a Catholic priest. On 4 occasions in 2010 a priest had to be brought in to complete a team for TCR to conduct a Weekend. Also 3 team couples had to be brought at different times so TCR would have a full team to conduct a Weekend. TCR paid for these team expenses

4b (Code:) (Expenses \$ 4,918 including grants of \$) (Revenue \$)
Post (weekend) sessions consist of a series of 12 presentations occurring usually weekly for 6 weeks following a weekend. Post sessions generally take place in a church facility, for which TCR currently pays \$ 200.00 for facility rental per the 6 weeks. The Post sessions provide in depth topics geared towards rebuilding couple relationships which expands the concepts taught on the weekend. A Post session team consists of 2 or more couples who present each post session. TCR completed 8 post series in 2010 in conjunction with the 8 weekends mentioned above. TCR is also required to purchase insurance for use of the church facilities.

4c (Code:) (Expenses \$ 8,420 including grants of \$) (Revenue \$)
Expansion occurs locally within TCR, regionally within our (North Central Region - NCR), as well as nationally and internationally. TCR tithes 5 % of it's gross donations to our governing body, Retrouvaille International (RI). TCR is represented at an annual International Council Meeting (ICM) by our Coordinating Couple and Priest. Voting on important changes to the Retrouvaille program occurs at ICM. TCR also provides funds to other smaller Retrouvaille communities (Northern Illinois in 2010) to help send couples to ICM.

This year TCR helped defray the cost of 9 TCR couples to attend the NCR Gathering (NCRG) in April. Each year, NCRG is held in a central location. NCRG gives couples a chance to be more involved with other Retrouvaille couples, learning and sharing their experience focusing on topical items such as recruiting, coordinating weekend schedules, training, workshops. TCR is one of largest Retrouvaille communities in the U.S. Expansion is served by supporting NCRG, providing a deeper understanding to especially new NCRG attendees as they gain confidence and dedication in practical ways to help hurting couples.
