



PFWP is currently facilitating parenting classes in the Minnesota Women's Correctional Facility in Shakopee (MCF/SHK); Minnesota Men's Correctional Facility in Faribault (MCF/FRB), Hennepin County Adult Detention Center for women and Volunteers of America Rentry Facility in Roseville for women. PFWP also provides an umbrella of support services to children of these parents through C.H.O.S.E.N., a volunteer-based support service that provides transportation to children and youth to see their moms at MCF-SHK. Supportive home visits are provided to encourage appropriate

The Mentoring For Life Change program is a one-on-one mentoring program created to break the intergenerational cycle of criminal behavior in youth affected by parental incarceration. Since July 1999, Mentoring For Life Change has made inroads in strengthening family relationships; improving or maintaining good behavior and academic progress in school; increased community service and career awareness in the lives of at-risk youth.

MLC program focuses on the expansion of services Parenting With Purpose provides to children and families affected by parental incarceration. This program is developed in response to a specific inmate need for assistance to restore and strengthen family relationships and to reduce and prevent the cycle of child abuse and neglect in families with an
