Purpose

The primary objective of the DFTI will be to work at the community level to develop and carry out both conservation and education projects that will build capacity within the local villages of Tanzania, East Africa. The underlying principle is that local communities must first understand the implications of their role in the custodianship of the protected areas of Tanzania and secondly be taught the leadership skills to participate in the on-going discussions and decisions about land use. DFTI will provide a vehicle for people interested in preserving wilderness and providing appropriate natural environments for Tanzania's wildlife to contribute to projects that are locally administered.

Projects will be in Tanzania, conducted by local conservationists, educators and schools.

DFTI is being formed to support two types of projects: community centered conservation and leadership education. In both cases, projects funded from other sources have been underway for several years that now require continuing support and new projects are anticipated. All projects have been and will continue to be administered by Dave, Michael and Thad Peterson who have been working for many years on projects designed to (1) offset negative trends which are jeopardizing the integrity of National Park ecosystems and (2) help educate future Maasai tribal leadership who will ultimately have to devise viable alternatives to the historical pastoral lifestyle of their people. The Petersons also own and operate Dorobo Safaris and Tours, Ltd., a local business that conducts safari tours in Tanzania.

Community centered conservation

Since 1991 the Petersons have been working with the approval of the Tanzania's Wildlife Division on two community-based conservation projects. Each is a small-scale attempt to set a precedent where wildlife and natural resource conservation can become a part of the land use/resource option mix available to local communities who are credited historically with custodianship of the most famous protected areas found in Tanzania (Tarangire and Serengeti National Parks). Currently projects initiated by the Petersons are also underway in: Oldonyo Sambu Wilderness, Soitorgoss Wilderness, The Yaida Valley, South Maasai Steppe and the Mzombe River. Oldonyo Sammu Wilderness area was established in 1994 in partnership with Maasai village of Emboreet to the east of Tarangire National Park. This wilderness is a critical part of the Tarangire ecosystem. All of the projects share the objective of combining business and community interests with conservation as the underlying outcome.

Education for Leadership

Since 1994 the Petersons have been working with Endulen Osootua Prep School (founded in 1988) and with OSEREMI (Oloirien Secondary Education Route and Eradication of Maasai Illiteracy) to prepare Maasai students to be able to attend further education so that they can educate the communities from which they come. These projects educate young Maasai men and women to assume leadership roles for their people who have become increasingly marginalized and impoverished. The education of future leaders is integral to the success of community centered conservation projects. Funding will be used to build school classrooms and provide basic training needs such as books, etc. In 2005, education was expanded to include an Orphans project. This project focuses on the education, training and counseling for Orphans to learn to live independently, become self confident and create a promising future for themselves.
