 Provide transitional housing and support services for women and their children who have experienced domestic violence. In 2010 fourteen battered women and their seventeen children received housing and support services. All of the women attended at least five hours of classes or programming each week, have participated in at least twenty hours of work, volunteering, or school and were given opportunities to grow in their faith through spiritual discipleship and Bible studies. Demographics of those served in 2010 are 62% Caucasian, 33% African American and 5% Asian. All residents considered below the poverty line and qualify for public assistance. They are also considered homeless by MN state definition. Half of the residents served in 2010 were ex-offenders five were long-term chronic offenders and two were first time offenders. Over the past twelve years over one hundred and fifty women and their children have been served. Most recently, one of the residents moved out on her own, completed her degree and began a job in a new career field starting at an annual salary of \$40,000.

 Community services such as domestic abuse outreach education. At least four volunteer trainings are held each year in which volunteers are educated on the current realities of domestic abuse as well as informed how to help the women and children they will serve. In 2010, over seventy different individuals volunteered with The Dwelling Place in a variety of ways. Many of these individuals went through the volunteer trainings and are directly involved in the services offered to the women. The Dwelling Place raises awareness about domestic abuse by educating volunteers as well as by speaking engagements in area churches and community events. These presentations average one per month. In October 2010 the executive director and board chairman served on a panel at a domestic violence rally in Chicago, IL. Information was given to the public at large. Also in 2010 the executive director participated in making a documentary called "I Believe You" on domestic violence which aired on ABC stations around the country. We send out regular newsletters to keep all constituents educated and informed.
