AS AN INTERMEDIARY, HEARTH CONNECTION COLLABORATES WITH STATE AND COUNTY GOVERNMENT, LOCAL NONPROFITS, TRIBAL BANDS, AND COMMUNITIES TO EXPAND SUPPORTIVE HOUSING OPPORTUNITIES AND OTHER PROVEN SOLUTIONS FOR PEOPLE EXPERIENCING HOMELESSNESS. IN 2010 WE SERVED OVER 1,300 PEOPLE- FAMILIES WITH CHILDREN, YOUTH, VETERANS, AND DISABLED ADULTS- STABILIZING PARTICIPANTS IN HOUSING AND DIVERTING THEM FROM CRISIS SERVICES AND LIFE ON THE STREETS. HEARTH CONNECTION'S DATA-DRIVEN, EVIDENCE-BASED PROGRAM IS HELPING TO BREAK THE CYCLE OF HOMELESSNESS.
