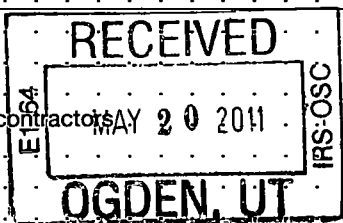



Part I - Line 10: The Bisexual Organizing Project exists to provide education and advocacy for bisexuals. The two major projects each year

to accomplish that are sponsoring the BECAUSE conference, which is a multi-day conference that provides educational opportunities

for bisexuals and their allies, and being present at Pride festivals around the upper midwest. By being at the Pride festivals we provide

space for bisexuals within the greater LGBT community. In 2010, \$8,441 was spent staging the BECAUSE Conference and \$903 was

spent for Pride registrations, materials, and travel to the cities where they were held.
