Castillo de Amor: the organization has a "street child" prevention and rescue program. Their program assists with education, family counseling, and basic human needs. They operate a organizational campus where temporary housing is provided along with other services. The goal of the program is to reintegrate the children into healthy, safe family environments. They can house up to 60 children and serve over 1,000 others through their programs and community efforts

4b (Code:) (Expenses \$ 20,600 including grants of \$) (Revenue \$)

Planta de Jemva: the organization operates two schools in one of the largest ghettos in Central America. It is located in the central part of Guatemala City. The school teaches, feeds, and cares for 300 children. They also reach out to meet needs within the families of the kids. They teach parenting classes. The organization also operates a "rescue house" so children in imminent danger can have safe shelter.

4c (Code:) (Expenses \$ 11,836 including grants of \$) (Revenue \$)

Nuevo Vida Para Santa Fe: This is a community center in the ghetto of Santa Fe - Guatemala City. They provide educational opportunities, tutoring, computer development activities to 50 children and their families. They are involved in various forms of humanitarian relief for a neighborhood made up of very poor families.
