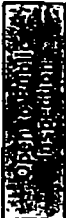

### **Memorial Event**

At least 300 people participate at an annual golf outing and auction on the anniversary of Travis Manion's death to remember his service and sacrifice and honor his love of country. Guests welcome veterans, families of the Fallen, and other beneficiaries of the Foundation to a day-long event.

### **Service Projects**

More than 5,000 volunteers completed service projects in 2010, including producing more than 20,000 care packages to more than 34,000 American military personnel in Iraq, Afghanistan and Qatar, building and maintaining Freedom Square which is an art project dedicated to remembering and honoring the Fallen, and more.

### **Team Travis Events**

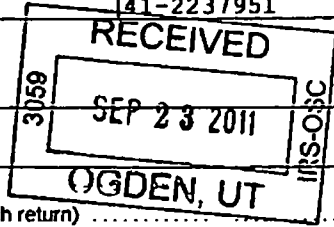
Team Travis events consist of Foundation volunteers participating in existing marathons and half marathons, triathlons, cycling events and other athletic competitions in various locations
