Events - 2010In 2010, the Autism Cares Foundation hosted 46 events throughout the year with total attendance at all events combined eclipsing 2,500 attendees These events and programs spanned a wide range of offerings giving appeal to many different age groups and ability sets, enhancing the life experiences of those that participated Our events ranged from monthly "bounce" outings, to "Autism Rocks" music events, bowling, movie nights, arcade outings and more We also created unique Halloween outings and our annual Holiday arts/crafts/autism rocks event We also began several programs which have a defined time span for participation in order for skill sets to be enhanced In 2010, these encompassed a weekly physical fitness program and a computer skills building program at our Learning Lab 2010 set a new record for number of events, diversity of events and total combined participation In 2010, we provided the local autism community with more choices for participation and as we look forward to 2011, we believe we can do more
