2. The revenue was \$12,061 in gifts from parishioners and friends of Our Lady of Victory Catholic Church in Davenport, Iowa plus \$2,944 in interest, dividends and capital gains.

3. The distributions made by the Foundation were only to Our Lady of Victory Catholic Church in the total amount of \$15,043.

Part II - All investments are in mutual funds at Edward Jones, Davenport, Iowa in various funds.

Part III - "To provide financial support to Our Lady of Victory Catholic Church, Davenport, Iowa for its church ministries and John F.

Kennedy Catholic School, a ministry of the Church."
