ARM has several programs that strive to meet the needs of inmates. The American Bible Academy is our free Bible correspondence school for inmates and their legal spouses. We are the distribution center for prison ministry for both American Bible Society and DaySpring. Bibles and Christian greeting cards are shipped to the institutions to be distributed to the inmates. We also distribute Christian literature, free of charge, to any chaplain who requests it through our "Box That Never Runs Dry" program.

Baptistries:
