Spring Break Mission Project to Sophia, North Carolina. Every year CCF goes to a different camp and spends 1 week doing work projects to fix, upgrade, and improve the camp. We brought over 200 students from Kirksville, MO to North Carolina all for \$150 per person (everything included). While at camp, we work, have time to play sports and games, have time for bible study and worship, and 1 free day to relax and see the area. Some years we have a surplus from this project, other years we run a deficit due to factors like fuel price, vehicle breakdowns, food costs, etc. Surplus will be used to fund the CCF Spring Break Mission Project to Mississippi in March 2011.

CCF Freshman week: When the freshman arrive to start the new academic year, CCF has a week of events to welcome old and new students. We have a meal that is free to students, games, giveaways, activities, worship, and a time to meet other students. Usually we will have about 300 students at each event. In 2010 we received a large gift from a church that sold closed and gave away everything. The excess from this year will fund the CCF Freshman Week event in August of 2011.
