- 1 **Residential Services** – The Women's Safe House (TWSH) Residential Services Program provided safe shelter and support services for 298 women and their 342 dependent children who were escaping violence in their own homes. We provided 16,736 nights of safety for these 640 women and children. Roughly 80% of the participants in the program left with a Personal Safety Plan and 85% of the residents indicated, via survey, that their knowledge about the issues of domestic violence has increased due to support groups, community presentations and case management sessions. The provision of a Parish Nurse to identify health care needs and prevention and a part-time Therapist to provide group and individual counseling has enhanced services and support to battered women and kids. The Women's Safe House continues to strengthen collaborations with organizations such as the Redevelopment Opportunities for Women Multi-lingual Access Program (MAP) and the Family Resource Center to comprehensively address the particular needs of survivors of domestic abuse.

We have strengthened our Living skills classes and added an evaluation component to measure its effectiveness. The Aftercare Program offers a safety net post shelter with one year of advocacy, case management and support groups. The Aftercare Program served 50 women and 79 children in 2010.

Expenses - \$668,092

- 2 **Crisis Hotline** – TWSH operates a 24-hour crisis intervention hotline staffed 365 days a year. The Hotline serves as the primary intake for shelter residents and provides advocacy for women in crisis or those at-risk of domestic violence. In 2010, 2,328 hotline calls were answered with compassion and care by trained staff and volunteers. Immediate advocacy and support along with information and appropriate referrals were provided for each woman upon her first call for help. The Crisis Line also provides support, advocacy, and compassion to victims of abuse who simply need to talk and seek information and referrals for community resources.

Expenses - \$141,201

- 3 **Children's Program** – The Children's Program is designed to meet the needs of infants, children and youth to age 18 who have witnessed and sometimes experienced violence in their homes. The Children's Program provides a comforting and nurturing environment where children can learn alternatives to violent behavior, improve their self-esteem and learn positive ways of expressing themselves. With a designated children's case manager liaison, some three-hundred and forty-two children benefited from child-centered services at TWSH in 2010. We continued to focus on children and youth interventions through a residential support program—Parent Education Program to Prevent Child Abuse & Neglect (PEPP-CAN) - but had to limit our efforts due to significant funding loss. A licensed therapist is available to work with residents to provide resources about communicating with children and youth and offers group and individual therapy for women and children. There are weekly support groups, field trips, holiday parties and age-appropriate play and child care.

Expenses - \$136,549

- 4 **Volunteers Program** – Volunteers make a difference at The Women's Safe House everyday. Volunteer efforts include serving on the Board of Directors, organizing fundraising and special events, organizing clothing and school supply drives, picking up donations, answering crisis calls, providing child care, working in the computer lab, assisting through clerical support or completing one-day projects such as painting residential rooms or helping with the grounds. The Volunteer Manager recruited volunteers through public speaking and outreach at schools and universities, churches, civic groups, business and corporate organizations, healthcare, social welfare agencies and United Way. During 2010, 1203 individual volunteers, nearly 100 individuals per month, provided 8108 hours of support for our programs. Forty-seven community presentations reached 1844 individuals. Our volunteer program is certified through United Way of Greater St. Louis.

Expenses - \$47,794

- 5 **Community Education** – The Women's Safe House remains committed to keeping our community informed about the problem and abuses associated with domestic violence. Trained staff and volunteers are available to speak publicly about and against domestic violence. Information is disseminated through public speaking, the agency's quarterly newsletter, annual report, and other materials. This year we reached out through new media vehicles such as ALIVE magazine, Ladue News, radio and television and the St. Louis Woman Magazine.

Total Program Expenses - \$1,024,691
