Changes are approved by the Board each year. The other employees are paid by the supported organization, The Saint Louis Art Museum. Salary surveys and studies are periodically used to determine their compensation.

Part II Line Biii Brent Benjamin's other compensation of \$149,000 should be split between a retention plan and a 403(b) plan. The Board approved a retention plan for the Director of the Museum in December 2007. The agreement was effective in 2008. The annual credit is \$100,000. Annual amounts specified at the inception of the retention agreement are paid to the plan pursuant to the terms of the plan (cont.)

Part II Line Biii (cont.) the retention plan is 100% at risk with payments contingent upon Mr. Benjamin remaining in the Museum's employment through the expiration of the agreement in 2013. The 403(b) plan contribution for 2010 was \$49,000. The remaining other reportable compensation of \$73,802 is for prior year's payout of unused vacation time.

Part II Line Bii Carolyn Schmidt's base compensation includes a one-time retention payment of \$500, net of taxes. The Board of Commissioners approved this one-time payment for all employees of the Museum, with the exception of the Director. No increases were made to her base salary in 2010.
