From the trust agreement, "Without limiting the general purposes of the Trust, the Trust shall have the additional purposes of receiving contributions, gifts, devises, bequests, grants, and other transfers of property, both real and personal, tangible and intangible, for the establishment, possession, maintenance, investment, and administration of a capital fund or funds for the benefit of the Columbia Weavers' and Spinners' Guild, Columbia, Missouri to assist the Guild in the carrying out of its public charitable, and educational purposes, and particularly to sponsor workshops, demonstrations, and seminars regarding weaving, spinning and other activities related to the practice and promotion of the craft of fiber arts "
