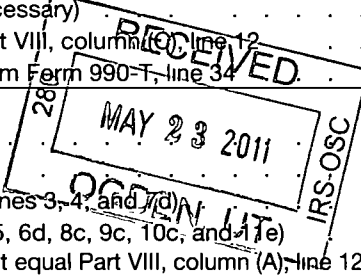

Promoting reading within the St. Louis County Library and the community as a whole is a primary objective of the Foundation. During 2010 the Gift of Reading program was expanded to include eight library branches and 3,500 free new books were distributed to preschool aged children. A donation of 1,400 books was made to a free clinic for children who have no health insurance.

Bringing in authors relevant to St. Louis County Library programming to talk about their works and sign copies of their books is another core program service. More than seventy author events for both children and adults were hosted by the Foundation during 2010.

Creating unique and comfortable spaces within library branches that are dedicated for the use of teens and children is a strategic objective for the Library. The Foundation helped facilitate the creation of four new spaces within libraries in 2010 and will complete funding for them in the next year.
