The Loop Trolley Company (the Organization) is a not-for-profit Missouri corporation whose purpose is to create, implement and operate a public street car system (the Loop Trolley Project) and to provide public education regarding vintage trolley systems The Organization is currently collaborating with the following municipalities, entities and organizations to develop the Loop Trolley Project Federal Transit Administration (FTA) East-West Gateway Council of Governments (East-West Gateway) The Loop Trolley Transportation Development District (the TDD) METRO City of St Louis, Missouri University City, Missouri St Louis County, Missouri Great Rivers Greenway Citizens for Modern Transit (CMT) Missouri Department of Transportation The Loop Trolley project will establish a public street car system that will connect Forest Park and the University City Loop, and will integrate two MetroLink stations In 2010, the FTA announced a \$24.9 million urban circular grant for the Loop Trolley Project The FTA funding will be divided into two grants the first portion, \$2.88 million, will be used to complete the project design and will be awarded to East-West Gateway (the Design Grant) The TDD will apply for the remainder of the grant, approximately \$22 million, for construction (the Construction Grant) The total project cost is estimated to be approximately \$43 million Additional funding for the balance of the project cost is being sought from multiple public and private sources, including the TDD, New Market Tax Credit equity (NMTC), tax increment finance district revenues and private donations In addition, the FTA funding requires a local match of (20%) The TDD has agreed to provide match for the Design Grant and additional match for the remainder will be provided primarily from private donations East-West Gateway has selected the Loop Trolley Company to serve as the Program Manager for the design phase, with Mr Tim Borchers, consultant to Loop Trolley Company, serving the key role in managing the work In the near future, East-West Gateway will issue a public request for qualifications to finish design of the project The consultant team selected will work at the direction of Mr Borchers, on behalf of the Loop Trolley Company and East-West Gateway The TDD will also issue a public request for proposal for a Program Manager to oversee the construction phase of the Loop Trolley Project and develop an operations plan for the public street car system The Loop Trolley Company anticipates that it will respond to the request for proposal and will submit a bid to be the sole contractor responsible for the development of the Loop Trolley Project
