The Foundation has developed a program to monitor & report on water quality in the entire upper White River basin region. No systematic & comprehensive assessment of this sort has been done previously and this project is intended to provide information to the general public in response to the question, "How is the water?". The Foundation has contracted with the U.S. Geological Survey and Missouri State University for the field work and analysis of water quality and in October 2008, the first "Status of the Watershed" report was issued. During 2009 and 2010 the Foundation continued this project with their now annual status of the watershed report interpreting both levels of water quality during the year as well as longer term trends. This work continues in 2011 with the annual report scheduled

4b (Code) (Expenses \$ **36,668** including grants of \$) (Revenue \$)

The Foundation continues to support public policy which promotes and protects water quality in the Ozarks region. Although the Foundation does not engage in lobbying activity, staff keep up to date on both legislative and regulatory issues and offers both opinion and recommendations to policy makers. The results of the Status of the Watershed report have led the Foundation to develop public policy recommendations which are being given to decision makers at the local, county and state levels. The Foundation has also stayed abreast of the discussions between Arkansas and Missouri pursuant to the Bi-State Agreement which the Foundation facilitated during 2008.

During 2010, the Foundation published a weekly email newsletter distributed to over 900 subscribers dealing with water quality issues in the Upper White River Basin watershed. In addition, our Foundation's website was enhanced to provide access to water quality information to the general public, regulators and legislators. The Foundation also help secure funding for the University of Arkansas to print a Low Impact Development (LID) Design Manual to be distributed to municipalities and other interested parties.
