The FAWCO Foundation awards Development Grants to projects nominated by FAWCO member clubs. Recipients are chosen after completing a thorough application process and all nominated projects undergo a vigorous review. The recipients are selected based on a vote by the FAWCO member clubs as outlined in The FAWCO Foundation Administrative Guidelines.

The FAWCO Foundation has a program to further support young women in Burkina Faso who wish to pursue studies after high school. We work with the Friends of Burkina Faso and NEEED (Nimbus, Enfance, Environnement, Education et Developpement, a local non-profit organization in Northern Burkina Faso) to create a fund for young women in at least three fields of study, one of which will be an academic university studies program. The fund will be generated through donations. The candidates are selected by the Friends of Burkina Faso and their progress will be monitored on The Foundation's website.
