of Florence Lake created this charitable trust. The will specifically lists the three

organizations that are to receive annually, 1/3 of the income of the trust. The Will states

that the Central Institute for the Deaf and the Community College of Devils Lake are to use

the funds to establish a scholarship fund to help students. The Will states that the amounts

paid each year must be distributed annually for scholardhips. The Devils Lake Area Foundation

is to use the annual payment for qualified charitable purposes and such funds are to be

distributed annually. The trust holds annual meetings. This meeting is attended by members of

the supported organizations. These three organizations submit an annual report regarding the

use of the funds.
