**RESOLVED:** That section 4.2 of the Bylaws of the Corporation is hereby amended by adding the following language to the end thereof:

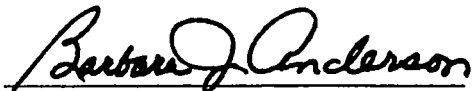

**FURTHER RESOLVED:** That a facsimile (fax) signature on this Consent Resolution shall be a binding signature and carry the same legal force as an original.

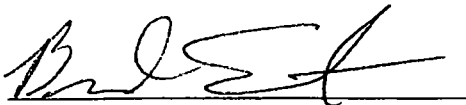
