 The Leesville Road church congregation had an average attendance of around 150 adults and 40 children, and around 250 active church members. The church moved into a 13,750 sq foot building on January 1, 2010, which the church currently leases with a view to purchase. The church was actively involved in supporting the poor in South East Raleigh, holding three large events during the year and serving food at least once per month. Approximately 100 people were fed and received clothing, gifts and prayer at each of our Christmas, Easter and Back-to-School events. The Back-to-School event including providing school supplies to around 40 families (note that detailed statistics are not kept on the exact number of people helped). In addition, 30 people in the congregation graduated from our 13-week leadership training courses run on Sunday mornings in the Spring and Fall of 2010. Over 40 people attended one of the congregation's 3 spiritual retreats, where they received pastoral care, spiritual refreshing and biblical training. The church also held a prophetic conference in September 2010, which approximately 500 people attended over 2 nights. Please note that the expenses include an allocation of indirect expenses that are not directly attributable to the cost center. In addition, the congregation is primarily funded by contributions from church members, the revenue shown above represents monies received from church members to cover costs of training, retreats and other events.

4b (Code: 900099) (Expenses \$ 99,214 including grants of \$ 0) (Revenue \$ 60,123)
 The School of Revival, a leadership school established in 2009 to train future church leaders and church planters, completed its first academic year 2009-2010, with 10 students graduating from the first year of the 2-year program. Of these 4 students returned for the second year in the 2010-2011 academic year. A further 15 students are enrolled in and are in the process of completing the first year program for the 2010-2011 academic year. All students are being trained in church leadership, preaching, care ministry, pastoral ethics and missions. Students also provided services to the community of Raleigh, including supporting a mentoring program at a local high school for students with English as a Second Language, and helping serve food and share the love of Jesus in a poor community in South East Raleigh. During the year the school was able to employ 2 full time teachers, who deliver the majority of the curriculum (15 hours per week), with support from the church pastoral team. Please note that the expenses include an allocation of indirect expenses that are not directly attributable to the cost center.

4c (Code 900099) (Expenses \$ 34,284 including grants of \$ 0) (Revenue \$ 2,650)
 Catch the Fire State is our congregation that meets on Sunday evenings at the North Carolina State University Campus. The congregation is a student and young adult church focused on reaching the students at NC State with the gospel of Jesus Christ. Attendance at the State campus increased during the year from 40 to 80 people, most of whom do not attend the Leesville Road congregation. The State congregation ran a leadership development program during the year, with 20 people graduating. The congregation also held a number of outreach events on Campus to raise the profile of the church and impact the students of NC State with the gospel of Jesus Christ. Please note that the expenses include an allocation of indirect expenses that are not directly attributable to the cost center. In addition, the congregation is primarily funded by contributions from church members, the revenue shown above represents monies received from church members to cover costs of training and other events.

Part III (3) While the Ministry did not cease conducting, or make significant changes in how it conducts, any program services, please note in our 2009 tax return it was decided to report program services as activities other than the week to week congregational services (Sunday) meetings. We have decided for 2010 and going forward that it is a more accurate reflection of the church's accomplishment of its exempt purpose and mission to include our Sunday congregational meetings that make up Catch the Fire Ministries as part of our program services, placing our management costs in a more realistic context. 2009 reported Program Services are included in congregational services results.

Part III (4d) Other program services were the Church's Junior and Senior High Youth ministries, which draw in young adults from around North Raleigh, many of whose parents are not in the church. The program has a strong outreach to youth at a skate park in North Raleigh.

Part VI (2) Duncan Smith (President) and Robert Savel (VP/ Secretary) have a business relationship with each other.

Part VI (4) The Church's Bylaws were amended and approved by the Board of Directors at their February 2010 meeting. The purpose of the revision was to bring the Bylaws into line with the Church's 501(c)(3) "church" status. There were no significant changes to the exempt purpose. The number of possible Board Directors was reduced from 21 to 7, and provision was made for the removal of Board members by the Board.

Part VI (11b) The completed 990, relevant schedules and 990-T were reviewed by the Board President and Treasurer, as allowed for in the Church Bylaws. The preparer (church accountant) provided hard copies of forms to President and Treasurer, who completed a line-by-line review of the 990 Forms and asked questions of the church accountant.

Once the President and Treasurer had approved the 990 forms the Form 990 and 990-T were signed by the President. Copies of the completed Return are provided to the other Board members following submission to the IRS.

Part VI (12a) & (13) The Board approved a written Whistleblower policy and a Conflict of Interest policy at their meeting in March 2011. The Bylaws include a provision for managing conflicts of interest at the Board level. The recently approved policy supplements these provisions and applies them to all staff and employees as well as the Board.
