The Faith Lutheran Foundation's primary objective is to disperse funds to agencies with programs that work toward charitable, educational, fine arts, religious or scientific goals. Grants are considered for programs in the greater Kansas City area. A Board of Directors of nine Foundation members serve three-year terms, that expire on a staggered basis. Membership is open to any person 18 years of age and older. A contribution of \$10 is requested.

The Foundation's by-laws require that grants only be made from the investment earnings in any single year, thereby allowing the corpus to grow when investment returns are favorable.

An annual solicitation for members is made in January of each year in advance of the Foundation's annual meeting in February. The Foundation has traditionally received contributions as memorials to past members and has been the beneficiary of decedent's estates. Receipt of funds from these sources is clearly uncertain and is not relied upon for yearly grants.

Grants are not to exceed \$4,000, are not to be given directly or indirectly to any church and no single entity will receive more than one grant during any 12-month period. Grants must directly address "people" needs; they are not given to offset administrative expenses. Religious affiliation or lack thereof will not be a consideration for making grants.
