CLIENT SERVICES INCLUDE PREGNANCY TESTS, PARENTING CLASSES, MATERIAL SUPPORT, POST-ABORTION RECOVERY, MARRIAGE AND FAMILY THERAPY, AND MEN'S PARENTING CLASSES. IN 2010 WE PROVIDED 1,250 PREGNANCY TESTS, 387 CLIENTS RECEIVED PARENTING CLASSES, GAVE MATERIAL SUPPORT VALUED AT OVER \$61,089 AWAY TO CLIENTS AND THEIR BABIES, PROVIDED POST ABORTION RECOVERY FOR 10 CLIENTS, MET WITH CLIENTS 857 TIMES FOR MARRIAGE AND FAMILY THERAPY APPOINTMENTS AND PROVIDED SUPPORT FOR MEN IN ALL OF THESE SITUATIONS.
