The Delaware Museum of Natural History (DMNH) opened its doors to the public in 1972 to excite and inform people about the natural world through exploration and discovery. As the only natural history museum in the state, DMNH welcomed more than 77,000 visitors in 2010 to experience an African watering hole, gaze up at a Giant Squid, encounter a jaguar face-to-face, and marvel at the diversity of shells from around the globe. Gallery highlights also include the only permanent dinosaur collection in Delaware, a simulated coral reef, and a Science in Action paleontology lab. Throughout the year DMNH also hosts several special exhibits on national tour.

None of the invested contributions have been restricted as to their use by the donors. The investments are accounted for as unrestricted board designated net assets.

The Museum has adopted the provision of FASB Interpretation No. 48 (FASB ASC 740-10-50), Accounting for Uncertainty in Income Taxes. Management continually evaluates

uncertain tax positions and expiring statutes of limitations, audits, proposed settlements, changes in tax law and new authoritative rulings, as applicable. In 2010, 8,262 children in schools and community organizations demonstrating dire financial need were able to visit the Museum or participate in an outreach program for free, with funding from the DMNH Scholarship Program. Scholarships are awarded to schools based on the percentage of students on the federally funded free or reduced lunch program, the State of Delaware's Purchase of Care program, or other such financial support.

(a) Type of Grant or Assistance: In 2010, the Museum was the recipient of a grant from the PNC Foundation for its Grow Up Great with Science initiative. The Grow Up Great with Science program is specifically designed to train preschool teachers to use their students' natural curiosity to foster experiential learning across curriculum areas using simple scientific methods. The Museum provides classrooms with materials and activities to create a science center as well as themed boxes to support the curriculum currently in use by the schools and to create an outdoor learning environment for use year-round. The Museum also provides training sessions for teachers to show how teachers can encourage children to look and observe, ask questions, explore topics with their senses and simple tools, and share with their teachers, classmates, and parents their own explanations about what they see in the world around them (both verbally and through hands-on projects).
