Charitable Outreach: The Foundation gives priority to those charitable organizations where medication adherence can have a positive impact on the health of patients. The largest share of our annual contributions budget is allocated to programs that address the health needs of patients, including patient, children's health, and community outreach initiatives. Proceeds from the Foundation Dinner, held annually in early December, support the Foundation's charitable outreach programs. The Foundation donated or provided grants to 35 charitable organizations.

Education:
The NACDS Foundation provides crucial Scholarship programs to Pharmacy Schools and individual Pharmacy students throughout the United States. 118 Pharmacy Schools and 58 individual Pharmacy students were awarded scholarships this year. The pharmacy school awards are designated for the school's scholarship funds for students.

The Foundation also offers education programs and resources for pharmacists, pharmacy technicians and pharmacy students.

The Foundation is generally exempt from income taxes under the provisions of Section 501(c)(3) of the Internal Revenue Code. Income from nonexempt functions is subject to unrelated business income tax. In addition, the Foundation has been determined by the Internal Revenue Service not to be a private foundation.

The Association follows the accounting standard on accounting for uncertainty in income taxes, which addresses the determination of whether tax benefits claimed or expected to be claimed on a tax return should be recorded in the financial statements. Under this guidance, the Association may recognize the tax benefit from an uncertain tax position only if it is more likely than not that the tax position will be sustained on examination by taxing authorities, based on the technical merits of the position. The tax benefits recognized in the financial statements from such a position are measured based on the largest benefit that has a greater than 50 percent likelihood of being realized upon ultimate settlement. The guidance on accounting for uncertainty in income taxes also addresses de-recognition, classification, interest and penalties on income taxes, and accounting in interim periods.

Management evaluated the Association's tax positions and concluded that the Association had taken no uncertain tax positions that require adjustment to the financial statements to comply with the provisions of this guidance. Generally, the Association is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for years before 2007.
