The Bishop Fellowship Program was inaugurated in 2000 to prepare senior faculty to assume positions of greater responsibility in academic medicine and health care leadership. It was developed because of the vision of F. Marian Bishop, PhD, founding member and former president of the Foundation, and is supported by the F. Marian Bishop Charitable Trust. This 1-year program works in partnership with the American Council on Education's ACE fellowship program. Fellows attend three week-long seminars on higher education issues organized by ACE, make three week-long visits to a medical school where the host dean or other administrator serves as a mentor, and attends other related conferences.

The STFM Group on Oral Health initially developed the award winning Smiles for Life National Curriculum in 2004. It has become the nation's most widely used oral health curriculum for primary care clinicians. This grant provided funding for development of an interactive web-based curriculum at www.smilesforlifeoralhealth.org. Smiles for Life was adopted as the primary education tool of the National Interdisciplinary Initiative on Oral Health.

The Society of Teachers of Family Medicine's Group on Immunization Education has developed and maintained the online Shots quick reference guide for childhood and adolescent immunization schedules. This is a collaboration of the Advisory Committee on Immunization Practices (ACIP), the American Academy of Family Physicians (AAFP), and an adult immunization schedule, recommended by the ACIP. Details on each vaccine are available by clicking on the vaccine names. The Shots schedules are located at www.immunization.org.

The STFM Foundation responded to the expressed needs of STFM members searching for funding for research and education projects by creating the Group Project Fund in 2008. It was established to promote the creative and collaborative research proposals of STFM group members. The fund encourages STFM group members to collaboratively plan, develop, implement, evaluate, and disseminate findings from educationally related scholarly projects. The outcomes of the projects will benefit group members, STFM, and the discipline of family medicine. Grants were awarded for 4 group projects in 2010.

Since the inception of the New Faculty Scholars Award in 1988, more than 100 STFM members have received these scholarship awards. The award is intended to provide STFM members who are in their first 2 years as full-time faculty and who exhibit outstanding leadership potential, the opportunity to attend the STFM Annual Spring Conference. This introduction to over 1,000 STFM members leads to community-building activities such as participation in groups and membership on committees and task forces. Three to seven scholarships are awarded annually.
