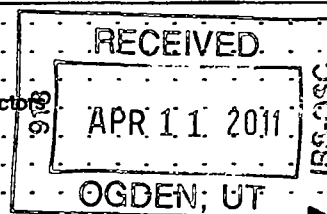

Part III**What is the organization's primary exempt purpose?**

The primary purpose for the organization is to provide assistance to Breslov Yeshiva (a religious school) and assistance for needy families and individuals. Also helping The Institute for the Blind, Orphan Home for Girls, Disabled Veterans, Children's Village, and Meir Panim (a soup kitchen).
