Training and Retreat Center: The CTWO Training and Retreat Center is a unique resource providing affordable and convenient meeting space to community groups and other non-profits who may not otherwise be able to afford a quiet, retreat-like setting. We offer very low-cost overnight accommodations to groups who are using the space as well as to local organizations who may be flying people in for a conference or gathering but cannot afford hotel lodging. The Victorian mansion (fondly referred to as the purple house by regular guests) has a meeting space and a sizeable kitchen on the first floor and dorm style overnight rooms for more than 30 people on the second floor. The facility has housed generations of transformative gatherings.

The Brown Boi Project works to build the leadership skills and economic self-sufficiency of young womyn of color who are masculine-of-center and young men of color who are trans/straight/queer. The project aims to help these young womyn and men to use their own skills and life experiences to build collective power within their communities. It also seeks to promote cross-racial alliance building within communities of color and to reduce the homophobia and violence that young people of color who don't conform to traditional gender norms experience from their own communities. Through leadership development, political education, exposure to community organizing, and the development of a personal life plan for each of our leaders, we offer a provocative reframing of masculinity and privilege that improves the lives of both individuals and their communities.

Grassroots Organizing: CTWO's current grassroots organizing project is the Black Organizing Project (BOP). It is a community-based organization designed to win real systematic change, build economic power, and create alternative models and institutions that will advance racial and economic justice. BOP works through a people-based approach to organizing as opposed to an issue-based approach.

Participants have become involved, taken ownership of the project, and begun exponentially growing the network of support in the community. In 2010 staff and members made over 2000 contacts in the community. From these, we have developed an active base of 739 community residents. Many community participants have attended CTWO training programs to develop their leadership and organizing skills. BOP participants engaged in a participatory research process around jobs and education and around public-policy issues such as criminalization and local-hire practices.
