Fresh Start Catering, an employment project of DCCK, is a full service catering company that employs graduates of the Culinary Job Training Program and provides specialized and advanced job training. In 2010, DCCK was selected by DC Public Schools to provide made-from-scratch meals for 7 elementary schools as part of a pilot project to improve the quality and nutrition of its foodservices.

Culinary Job Training -- DCCK's 12 week training program empowers men and women, many of whom are homeless and unemployed, to provide for themselves and their families by learning professional foodservice skills.
