 Financial Assistance Program - ODB staff coordinate volunteers for the Financial Assistance Program. Volunteers answer calls from referring social agencies (Fairfax County government, Fairfax County Public Schools, and non-profit organizations) and evaluate requests for financial assistance grants. ODB provides grants to meet basic needs such as rent, utilities, car repairs, and medical bills. ODB provided a total of \$416,200 in financial assistance grants to 333 families in 2010.

4b (Code:) (Expenses \$ 372,452 including grants of \$ 339,366) (Revenue \$ 0)
 Food Program - ODB's Food Program consists of a food outreach program and food pantries. For the food outreach program, the staff coordinates approximately 30 participating volunteer organizations to collect, bag, and deliver groceries and household items to needy families on a weekly basis. ODB also operates 2 food pantries, where donated food and household goods are collected and distributed. ODB provided food assistance to 442 families in 2010.

4c (Code:) (Expenses \$ 175,322 including grants of \$ 148,343) (Revenue \$ 0)
 Special Projects - Special Projects consist of two main programs:
 1) Back to School Program - ODB solicits donations from individuals, corporations, and community groups to provide school supplies to children in the Fairfax County area. In 2010, school supplies were provided to 337 children.
 2) Holiday Program - The program matches families in need to local community groups, businesses, and individuals willing to "adopt" a family by providing meals and holiday gifts. Unmatched families are provided with gift cards.
 In 2010, ODB served more than 4,584 families in the Holiday Program.

The Financial Literacy Program provides trained volunteers to educate clients in basic household budgeting and understanding credit. Education is provided through one-on-one counseling and small group counseling. In 2010, ODB also coordinated the "Pathways to Independence; Financial Fair for Young Adults" event held at a local high school to promote financial literacy among Fairfax County youth. For the Community Education Program, ODB visits businesses, community and religious organizations, publishes newsletters and e-newsletters, and maintains a website in order to educate the public about ODB's mission and the plight of the working poor in Fairfax County.
