- a) To assist Christians who are victims of oppression by upholding them by prayer, intercession, and other practical means,
- b) To raise public awareness and to solicit public and political involvement in the process of defending human rights and improving conditions for persecuted Christians;
- c) To research, evaluate and effectuate policies that would safeguard religious freedom as a fundamental human right as guaranteed by international covenants;
- d) To cultivate partnerships with other Christian organizations that share similar concerns, seeking to foster unity through cooperation and support.

In order to pursue its objectives, ICC will take all appropriate measures (i.e., through information to the public, contacts with churches, political and humanitarian organizations, gathering of signatures, petitions, direct support for those suffering persecution, holding of religious and prayer services of intercession, and any other which shall be deemed Christian in its conduct, and will be of benefit to the persecuted Believers). ICC rejects and is opposed to any type of violence in reaching its objectives and shall not tolerate use of violence in any form.

ARTICLE III – AUTHORITY

The President of ICC shall manage the resources of ICC to assure that these objectives and principles are adhered to.

ARTICLE IV – OFFICE

Section 1 Principal Office The principal office of the Corporation shall be at 8555 16th St, Suite 805, Silver Spring, Montgomery County, Maryland 20910.

Section 2: Other Offices. The Corporation may also have an office or offices in such other place or places as the business of the Corporation may require and the Board of Directors may from time to time appoint.

ARTICLE V – ORGANIZATION

Section 1: OFFICERS. The Officers of this corporation shall be a President, one or more Vice Presidents, Secretary, and Treasurer.

Section 2: BOARD OF DIRECTORS. There shall be a Board of Directors with no less than three (3) members and no more than eleven (11) members.

Section 3: ELECTION OF OFFICERS AND BOARD OF DIRECTORS. Officers and Board Members shall be elected at the Annual Meeting of the Corporation or other meetings as may be called by the Chairman or President. Officers and Board Members shall serve for a period of three (3) years and shall be eligible for re-election. No more than one paid staff member can serve on the board. Officers and Board Members can be removed from office anytime by a majority vote of the Board of Directors.

Section 4: NOMINATING COMMITTEE
A Nominating Committee shall be elected each year at the Annual Meeting of the Corporation consisting of at least two (2) board members to review qualifications of potential new board members. The chairperson of the Nominating Committee will be selected by the Board Chairman. The Nominating Committee will provide the board with timely due diligence findings and recommendations regarding suitability for board service for potential board members.

Section 5: BOARD COMMITTEES. The Board of Directors may establish other committees to assist in its role of providing oversight of the organization and setting policy. Such committees may be established by the board, or by its chairman. Committees of the board will report to the board and be under the authority of the Board. Board committee members that are not members of the Board of Directors may be appointed, but a member of the board must serve as the chairperson. Members of board committees serve without compensation.

ARTICLE VI – MEETINGS

Section 1: ANNUAL MEETING. There shall be an Annual Meeting of this Corporation held at such time and place as shall be determined by the Board of Directors. The Annual Meeting shall conduct the following business:

- 1) Election of the officers and Board of Directors when their terms are to expire;
- 2) Ratification of the Annual Report and the Annual financial Statement;
- 3) Amendments and changes to the Bylaws;
- 4) Such other business to come before the Board of Directors.

A simple majority vote of those present and voting shall be sufficient to decide all matters at an Annual Meeting.

Section 2: OTHER MEETINGS. Other meetings may be held upon call of the President, Chairman, or upon petition of a simple majority of the Board Members made in writing to the Chairman or President, indicating the reason for calling the meeting. An agenda for each meeting will be distributed to each Board member at least five(5) days before the meeting. A simple majority vote of those present and voting shall be sufficient to decide all issues at these meetings.

Section 3: QUORUM. A quorum for all meetings of the Corporation shall consist of at least one-half of the currently elected Board members being present either physically, by telephone, or other electronic means.

Section 4: VOTING AT MEETINGS. Members of the Board of Directors who are either physically present or present by telephone or other electronic means, shall be eligible to vote at meetings of the Corporation.

Section 5: NOTICE OF BOARD MEETINGS. A notice for all Board meetings shall be given in writing along with a preliminary list of agenda items for the meeting, mailed to the last known address of all the members of the Board of Directors at least two (2) weeks prior to the date of the meeting.

Section 6: PRESIDING OFFICER. The Chairman of the Board of ICC shall preside at all meetings of this Corporation, or, if he is not present, by the Vice-Chairman, or if none of said officers is present, by a chairman to be elected by the Board Members present.

ARTICLE VII – FINANCIAL POLICY

Section 1: NON-PROFIT STATUS. ICC is a non-profit charitable corporation and all finances shall be used exclusively for such objectives as set forth in these bylaws and the Articles of Incorporation. The Officers and Board Members of ICC shall have no claim whatsoever to any profits which may be earned. No officer or member of the Board of Directors shall receive any remuneration from ICC except the normal salaries and expenses incurred in the exercise of their office.

Section 2: BUDGET. The President shall make up a Proposed Budget each fiscal year, which shall be ratified by the Board of Directors.

Section 3: SOURCE OF REVENUE. The source of all funds for ICC shall normally consist of the following:

- 1) Voluntary donations and requests from churches and individuals;

- 2) Proceeds from love offerings or collections;
- 3) Proceeds from the publication of printed matter or special fund-raising events;
- 4) Contributions from foundations and corporations;
- 5) Contributions from ministry partners.
- 6) Earnings from invested funds.

Section 4. ANNUAL AUDIT. Each year the Board of Directors shall contract with a Certified Public Accountant who shall audit the financial records of ICC and shall publish his findings by June 30th of the following fiscal year in the form of a Financial Report. The Annual Audit Report shall be made available to all members of ICC and any other interested parties who may inquire.

Section 5: FISCAL YEAR. The fiscal year of ICC shall be from January 1 to December 31.

ARTICLE VIII – PARLIAMENTARY AUTHORITY

The latest edition of Robert's Rule of Order, Revised, is the authority for parliamentary rules of procedure for all business meetings of this Corporation.

ARTICLE IX – OPERATIONS

The President shall oversee operations of the Corporation to ascertain operations are consistent with the corporate purposes and policies which might be established by the Board of Directors from time to time.

ARTICLE X – DISSOLUTION

Four (4) weeks subsequent to the announcement in writing that dissolution of the Corporation is under consideration, the Annual or Special Meetings may resolve, in a meeting called for such a purpose, that the Corporations to be dissolved, provided that the Board of Directors of ICC has consented and so advised that those in attendance shall vote in favor of such dissolution with a simple majority for dissolution

In case of Dissolution of ICC all funds, property or other matters belonging to ICC shall be given to a non-profit Christian organization whose objectives and aims most nearly conform to those of ICC and is recognized by the Internal Revenue Service as a qualified 501(C)(3) organization.

Further, it is understood that the Board of Directors of ICC shall at all times have the exclusive power and authority, notwithstanding any other provisions herein, to dissolve, liquidate, and terminate the Corporation, and to control its objectives both within or without the State of Maryland and United States of America In the event of the dissolution of ICC, its assets shall be

distributed according to Article X Dissolution and internal Revenue Code 1954, Section 501(C)(3) or any subsequent amendment thereof.

ARTICLE XI – AMENDMENTS

These Bylaws may be amended by a simple majority vote of Board Members present and voting at any Annual or Special Meeting of this Corporation called for that purpose, except that the proposed amendment must be made in writing and presented to each Board Member at least two (2) weeks prior to the call of the meeting where the amendment will be considered and the vote taken.

ARTICLE XII INDEMNIFICATION

To the greatest extent provided by law, members of the Board of Directors, officers, and staff of the corporation will be indemnified and held harmless from claims brought by third parties, including costs, judgments, causes of action, attorney fees, and any other expenses arising out of, or related to their service as directors, officers, and staff acting in any official capacity for the corporation
