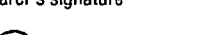

1. Saving, Planning and Paying for College Workshop Series (\$11,102.33)

Saving, Planning and Paying for College is a nationwide program sponsored by The Sallie Mae Fund that visits local communities to increase awareness among high school students and their parents that a higher education is accessible. In each community, this 30-90-minute workshop covers topics such as: the benefits of continuing an education beyond high school; the affordability of college through various types of financial aid available (i.e., grants, scholarships and loans); and resources available to help families prepare for the college-admissions process. One future college student at each workshop wins a \$500 scholarship toward the cost of a college education. During 2010, The Fund:

- Conducted 10 free Paying for College workshops.
- Reached 850 students and parents.
- Partnered with organizations and schools, such as Communities In Schools and the Loudoun County Public Schools, and co-hosted with three policymakers.

2. Educational Materials (\$15,938.40)

In 2010, The Sallie Mae Fund distributed over 61,000 free educational materials to help families plan and pay for college at events and online, including:

- 23,250 Mission Possible books
- 15,940 "Top 10 Tips for College Admissions and Financial Aid" cards, available in 11 different languages.
- 12,509 copies of Saving for College Brochure, available in English and Spanish

- 353 Black College Dollar Scholarship Directory.
- 1,836 Scholarship Fact Sheets.

3. Community Outreach (\$1,500.00)

The Sallie Mae Fund supports the communities where Sallie Mae employees live and work by encouraging a culture of community support and volunteerism. In 2010, The Fund supported a number of local efforts, as well as national programs with Reading Is Fundamental and the corporate-wide Dollars for Doers program.

4. Kids2College (\$0.00)

Kids2College is The Fund's early-college awareness program. This six-session curriculum is taught within schools and community groups to middle school students and encourages them to start thinking about college. In 2010, The Fund:

- Continued to provide training to college-access partners nationwide.
- Continued to offer its national core curriculum and online community to support program partners.
- Reached roughly 15,000 middle school students at 86 schools in partnership with 33 colleges and universities.
