American Strategy Program The purpose of the American Strategy Program is to promote a new internationalism that adapts our best foreign policy traditions to the 21st century, combining tough-minded realism about America's interests in the world with pragmatic idealism about the kind of world order best suited to America's democratic way of life. The American internationalist tradition that guides the American Strategy Program understands that international peace and stability in this new century rests as much on economic prosperity as it does on collective security, meaning socio-economic development, collective security, and democracy-building must be pursued in concert with each other. We must therefore seek to build a system of international law and governance that restores legitimacy to American power while pooling global resources to address common transnational threats. Through a program of original research and publication, the American Strategy Program seeks to build a new consensus around these core ideas of American internationalism, and the specific strategies they suggest. The American Strategy Program wrote 90 articles and policy papers, held 40 public policy events and had 516 media appearances.

The Committee for a Responsible Federal Budget wrote 34 articles and policy papers, held 2 public policy events and had 248 media appearances.
