The student body for the academic year ending in May 2010 consisted of 73 students, while the enrollment as of September 2010 was 72 students. Approximately 700 dancers were auditioned during a six week audition tour early in the year that included 12 different cities in the United States. Many of these were selected to attend intensive training sessions held in the summer at the Kirov Academy. Total enrollment for the summer sessions was 300 students. The school also staged concerts which were held in our studios in May and December for the sake of parents and invited guests.

(Revenue \$) On June 24 we transferred our school building and land located at 4301 Harewood Road NE, Washington DC, to an affiliated 501(c)(3) charity that has agreed to let us operate our Ballet School in perpetuity on the premises, as long as we continue to operate it in substantially the same manner as in the past. The estimated value of the school building and land was \$6,000,000.
