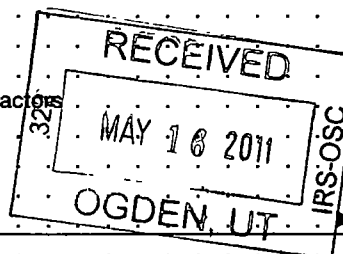

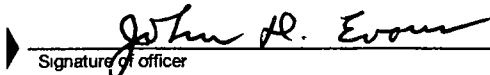

Please refer to Part III, Line 28. Friends of the Dominican Republic is a small, all-volunteer organization comprised of former Peace Corps Volunteers and staff who served in the Dominican Republic. We raise funds to support the mission of the Peace Corps and the work of the Volunteers in their communities. Our money is technically donated to the US Peace Corps' Partnership Programs, although the funds are ultimately transferred to the local office in Santo Domingo via the State Department/US Embassy financial system. In 2010 we provided \$13,215 to fund six small-scale projects in Dominican communities. In addition, we provided \$1,572 for pipe-threading equipment, a hand-held GPS and six Abney levels to assist Volunteers in designing, measuring and building fresh water supply systems.

Part I, Line 20, Other changes in net assets or fund balances

Friends of the Dominican Republic has a project reserve account consisting of mutual funds and cash. We use the earnings from the account, interest and dividends, to fund community development projects described above in Part I, Line 10. After several years of poor performance, the market improved in 2010 and the Net Asset Value of our shares increased by \$13,086. This amount is computed simply by adding our 2009 Year-end total (\$194,794) to our 2010 donations/dues/investment earnings (\$26,590) and then subtracting all 2010 expenses (\$20,822). The resulting difference between the result (\$200,562) and the actual value of our 2010 Year-end total (\$213,628) is explained by an increase in Net Asset Value.
