Dr. Edgar Rodas, President, made presentations in Stanford, CA; in Fort Lauderdale, FL to NOVA Southeastern University; and at a fundraising event in Washington, DC.

More than 99% of Cinterandes support is from contributions. It has 2 to 4 contributors of \$10,000 or more each year, it averages 4 additional contributors of more than \$1000 each year, and it averages 14 additional contributors of less than \$1000 each year.

Cinterandes' activities directly benefit the general public on a continuing basis. Each year it provides funding for surgical procedures for people in remote areas of Ecuador, that cannot afford to pay for the surgical procedures they need. The Directors and Officers include 5 medical doctors, 1 homemaker, 1 illustrator, 1 judge, 1 engineer and 2 administrators.
