Program Accomplishments

In July 2010, REDF was awarded a two-year, \$3 million federal Social Innovation Fund (SIF) grant to implement its five year strategy by deepening its presence in the San Francisco Bay Area and expanding to other communities in California. By 2015, REDF aims to establish the social enterprise model as a sustainable pathway to employment for chronically unemployed Californians who, even in the best economy, are unable to find work; demonstrating what can eventually be done throughout the country to create jobs, contribute to local economies, and employ thousands of people.

The SIF award recognized and validated the work of REDF, and the nonprofits that have been part of its portfolio. In April 2010, REDF also convened more than 50 job-creating social enterprises from around the country to explore how to collaborate and accelerate business growth. The participants will form the nucleus of a REDF-convened group that play a key role as we craft a nationally replicable model of social enterprise. REDF also was a keynote speaker or presenter at multiple venues invited by distinguished leaders ranging from the Mayor of Fresno to Stanford's Center for Social Innovation.

With REDF's 2010 investments, the organizations in **REDF's portfolio** continue to expand their social enterprises, create new jobs and employ people who would otherwise face limited prospects for entering into and staying in the workforce. Highlights of REDF's business and capacity-building work with these organizations include:

Buckelew Programs

- Finalized new social enterprise business plan and began start-up.
- Buckelew Programs' cleaning service increased job slots and people employed.

Community Housing Partnership (CHP)

- Developed a marketing/re-branding strategy and implementation plan for enterprises.
- CHP's desk clerk staffing business increased number of job slots and people employed.

San Francisco Conservation Corps (SFCC)

- With the help of REDF's Farber Fellow, Intern, and REDF staff, SFCC's Special Events Enterprise is on track to increase the number of special events where it provides recycling services by year-end 2011.

Society of St. Vincent de Paul, Alameda (SVdP)

- Increased transitional job slots through job subsidies and partnerships.
- SVdP's electronic waste recycling business increased revenue.

In terms of REDF's influence in the field of social enterprise, REDF has produced two notable publications in 2010 which will be disseminated strategically in the coming months:

- **REDF Social Outcomes Tracking Findings**

From 1998 – 2008, REDF contracted with BTW Consultants to collect pre-post data on social enterprise employees. Newly hired social enterprise employees were offered the opportunity to participate in baseline interviews, and those who participated in the baseline were contacted every 6 months for up to 2 years. Over this period, over 1100 baseline interviews were conducted, and roughly 500 people were tracked for at least 18 months.

Program Accomplishments

- **Mathematica Evidence Scan**

In addition to analysis of its own data, REDF is dedicated to learning from others working in social enterprise, transitional jobs and workforce development. In early 2010, REDF contracted with Mathematica Policy Research Inc to conduct an evidence scan of work programs for people with barriers to employment.

Brokered relationships between social enterprises and private sector companies/public agencies that resulted in the following:

- A \$385,000 procurement by Safeway from Ashbury Images (a social enterprise of New Door Ventures—a former REDF portfolio organization)
- A contract between Electronic Recyclers International and REDF portfolio organization St. Vincent de Paul of Alameda County;
- \$2.4 million commitment from the State of California to start up a social enterprise employing parolees in Oakland (March 2011 start date);
- A \$400,000 federal grant for expansion of REDF portfolio member Community Housing Partnership's social enterprise
- Ongoing exploration of procurement potential with real estate companies; health care companies; educational institutions; and other private companies.

REDF invested considerable time and resources into expanding the management capacity of **social enterprise leaders**. One key way this was accomplished was through REDF's signature Farber Program which deployed MBA interns in each portfolio organization during the summer of 2010.

REDF's 2010 **Benefit and Social Enterprise Expo** was a sold-out success with more than 400 guests gathered to honor Secretary Matthew Cate of the California Department of Corrections and Rehabilitation and philanthropists Mitch and Freada Kapor who all received the inaugural REDF 2010 Inno+prise. With the generous support of corporate sponsors, Host Committee members, and many event guests, REDF raised \$136,000 to support its job creation efforts in California.
