The Foundation does not engage in extensive fund raising but does have a continuing program to remind the Church's congregation and other interested parties of the opportunities to assist others through contributions to the Foundation. Resources are provided to the Foundation through numerous small contributions in the range of \$25 to \$500 and infrequent large contributions and bequests of \$5,000 or more. The fluctuating levels of contributions and the relatively large proportion of restricted principal funds means that investment income usually represents a substantial proportion of the funds available for Grants and Loans. Investment income and contributions are subject to considerable fluctuation from year to year depending upon the economic conditions and the securities markets, as well as the desires of contributors. Consequently, calculated "Public Support" may often be less than the 33.3% of "Total Support".
