Braxton County Memorial Hospital serves as the gateway for the healthcare needs of the citizens of Braxton County and the surrounding areas. Its mission is "Caring for you close to home." The hospital provides inpatient, outpatient, home health and emergency medical services to residents of Braxton County, WV and surrounding communities.

Services provided by the hospital included 1,435 inpatient days of care, 17,971 outpatient visits, 11,099 emergency room visits, 3,675 home health visits and 6,443 clinic visits. Charges forgone for charity care amounted to \$101,456. The hospital is designated as a critical access hospital and serves a mountainous, rural area of West Virginia.

(Code) (Expenses \$ 35,627 including grants of \$ 35,627) (Revenue \$)

The hospital offers a tuition reimbursement plan that is designed to encourage participation in courses offered by an accredited two (2) or four (4) year state-supported college or university. The plan applies only to tuition and books and all course work must relate to the employee's current position or a future position needed within the hospital. Employees who receive assistance under this plan must remain employed after the completion of the course of study for an amount of time equal to the time during which tuition reimbursement was received. The hospital has also developed a Loan Repayment Program to attract well-qualified candidates to skilled health care positions that are in critical shortage at the hospital. Candidates must be applying for regular full-time or part-time employment in a critical skills position. Payments under this program are directly to the educational and/or lending institution(s). Candidates who receive loan repayments under this plan must remain employed at the hospital for a period from three to five years, depending on the amount of the loan.

The hospital serves as an educational site for the West Virginia Rural Health Education Program (RHEP). We provide office space, conference rooms and student rotations for this program. Through this program, 177 medical, dental, pharmacy and nursing students were placed in educational rotations. Of this number, 24 were directly placed in Braxton County. They completed 218 community service projects. This program also offers cardiac kids, a health screening program for elementary students throughout north central West Virginia. Last year, 12,886 community members in a five-county region participated in these various screenings and projects.
