Friends of Blackwater's work led to the protection for the federally owned Blackwater Canyon Rail Trail in 2010 which we have worked since 2002. In July 2010 the USDA Forest Service declared that the historic Blackwater Canyon Rail Trail would not be used by a private timber company for use as a logging haul road. This significant victory was due to the pressure from the public, business owners, and conservation and historic preservation groups who worked tirelessly with Friends of Blackwater to keep the trail open for the public. The decision protects four rare species in Blackwater Canyon and the historic coke ovens, bridges and cut stone archways that line this National Register eligible rail corridor.

4b (Code: NFWP) (Expenses \$ 40078.57 including grants of \$ 540.00) (Revenue \$ 0)
This project was created in 2002 to improve this gateway to the Blackwater Canyon. The North Fork flows along the Blackwater Canyon Rail Trail by historic coke ovens and railroad bridges. The NFWP works with state and federal agencies to remediate acid mine drainage degrading the North Fork, a polluted tributary of the Blackwater River. The Project presented programs on water quality to students, community groups, Boy and Girl Scouts and 4-H Clubs. The Project worked with the town of Thomas to build a trail system in the Thomas City Park along the North Fork. A Major report on the North Branch of the Potomac was completed in 2010. Our Vista Volunteer and two part-time employees monitor water quality in the North Fork with volunteer help. Our 2010 summer Visa Volunteer, Evan Supak, studied streams in the Blackwater Watershed with potential for reintroducing native brook trout. We worked on the website based on the Google Earth outreach tool explaining water quality in the Blackwater and North Branch of the Potomac.

4c (Code: SOS) (Expenses \$ 42165.94 including grants of \$ 0) (Revenue \$ 0)
Friends of Blackwater has been working for ten years to protect "Ginny", the rare West Virginia northern flying squirrel, the most unique mammal of the Allegheny Highlands and the signature species of Blackwater Canyon. In 2008 the US Fish and Wildlife Service removed all federal protections from this Appalachian flying squirrel. The Friends filed a notice letter and brought a lawsuit against the federal government against the Fish and Wildlife Service's delisting. We built a coalition of groups around this effort, did research to assist the lawyers in preparing briefs and tracked actions that could threaten Ginny and her habitat. Oral arguments presented by Jessica Almy were heard in front of Judge Emmett Sullivan on November 17th.

JR Clifford Project which educates citizens about West Virginia's first African-American lawyer who fought in the Civil War, was a newspaper publisher and a co-founder of the Niagara Movement, the predecessor of the NAACP. We presented a play about Clifford's famous civil rights case of 1892. The Project did presentations on Clifford's life to school assemblies around the state. We completed an elementary school curriculum on Clifford. Inspired by Clifford's contribution to the state we created a map and poster on West Virginia's African American Heritage. Nine thousand posters have been distributed to high schools, museums, libraries and visitors centers around the state. The new map was funded by grants from the WV Community Participation Program of the West Virginia Legislature.

Friends of Blackwater has advocated for a national park in Blackwater Canyon and the surrounding area since we were founded in 2002. We have used these funds to create an Advisory Board, to write a strategic plan and to create materials to share with decision makers on the proposed park.
